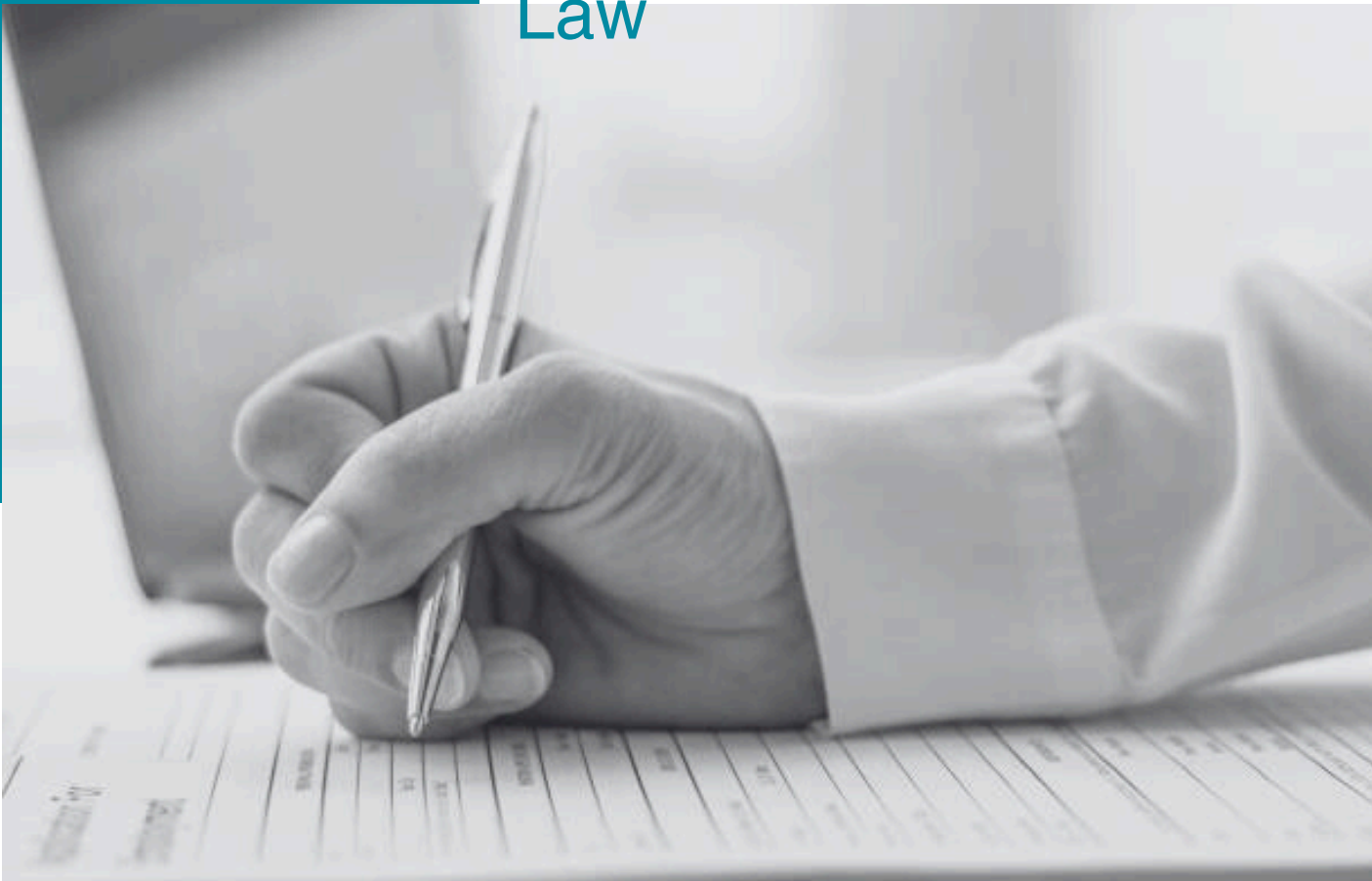

Administrative & Public Law
